OFFICE ORDER

Based on the resolution of meeting of the Disciplinary Committee held on 12/04/2018 at 04:30 p.m. and subsequent interrogation/submission/interaction with the students charged against indisciplinary activities, the following penal action have been recommended.

1. Sanjay Pradhan (14/BT/53) and Souvik Das (14/BT/72) who have produced false document for mess-bill payment and also cheated their friends Shiv Kumar Anand (14/BT/90) and Nakul Das (14/BT/32) by handing over false bills to them against their payments are debarred from sitting for the ensuing regular even semester examination, 2018. However, they are permitted for writing in even semester supplementary examination, 2018. They are also required to pay a fine of Rs. 15,000/- (Rupees- fifteen thousand only) each on or before 24/04/2018.
2. Shiv Kumar Anand (14/BT/90) and Nakul Das (14/BT/32) who unknowingly produced false bills handed over by Sanjay Pradhan (14/BT/53) and Souvik Das (14/BT/72), are required to pay fine of Rs. 5,000/- (Rupees- five thousand only) each on or before 24/04/2018 for sitting in the regular even semester examination, 2018.
3. All the following students, who have produced false document for mess-bill payment are fined with Rs. 15,000/- (Rupees- fifteen thousand only) each, to be paid on or before 24/04/2018 for sitting in the regular even semester examination 2018.
