

NOTICE

Sub: Refund of tuition fee to the SC/ST/PwD/stipulated family income level students who were admitted in B. Tech / Dual Degree / Integrated Programme 2017-18.

1. From the records it appears that -
 - a. There are 101 students of SC category, 49 students of ST category and 14 students of PwD category who were admitted in B. Tech / Dual Degree / Integrated Programme 2017-18 and deposited Rs. 20,000.00 to JoSAA / CSAB 2017, eligible to get full remission of tuition fee on deduction of Rs. 11,450.00 towards OCF and therefore will get a refund of Rs. 8550.00 per student.
 - b. There are 125 students who were admitted in B. Tech / Dual Degree / Integrated Programme 2017-18 with family income less than rupees one lakh only per annum and deposited Rs. 45,000.00 to JoSAA / CSAB 2017, eligible to get full remission of tuition fee and on deduction of Rs. 11,450.00 towards OCF and therefore will get a refund of Rs. 33,550.00 per student.
 - c. There are 98 students who were admitted in B. Tech / Dual Degree / Integrated Programme 2017-18 with family income is between rupees one lakh only to five lakhs per annum and deposited Rs. 45,000.00 to JoSAA / CSAB 2017, eligible to get 2/3rd remission of tuition fee with payment of Rs. 20,834.00 as tuition fee and on further payment of Rs. 11,450.00 towards OCF and therefore will get a refund of Rs. 12,716.00 per student.
 - d. There are 30-31 students who were admitted in B. Tech / Dual Degree / Integrated Programme 2017-18 deposited an amount other than as mentioned above will be eligible to get a refund of appropriate amount, which will be dealt on case to case basis individually.
2. Individual students who were admitted in B. Tech / Dual Degree / Integrated Programme 2017-18 and eligible as mentioned under 1a to 1d above, may apply in the prescribed format as enclosed providing all the required documents / details to Mr. Kaushik Ranjan Kar (Room No. 4 of the Academic Section) from April 09, 2018 to April 18, 2018 in between 15.30 hrs to 17.00 hrs on working days.
 - Enclose self attested photocopy of payment to JoSAA/CSAB 2017
 - Enclose self attested photocopy of valid SC/ST/PwD/Family Income Certificate submitted on the date of admission
 - Enclose self attested photocopy of payment of registration fee for 2nd Semester 2017-18
 - Enclose self attested photocopy of any further payment towards the Institute at the time of admission in 2017 if any
3. The student himself / herself should be the holder of the account to which the refund be made and all such bank account detail should also be checked individually and entered in the database of Academic Section at the time of submission of complete format with documents within stipulated time period.
