CIRCULAR

This has reference to the earlier circularvide NO. NITD/Estt./CoVID-19/2021/5 dated 24/05/2021 issued regarding administrating vaccination against CoVID-19 to permanent employees, their dependent members and retired employees of NIT Durgapur within the NITD campus. This is for your kind information that the Institute administration had been in regular contact with district administration and various other agencies for facilitating vaccination within the NITD premises. In response one agency ,i.e IQ city Hospital, Durgapur has given their consent and received necessary approval from the Government to create a **CoVID-19 Vaccination Centre (CVC)** at our campus. Accordingly, vaccination drive is going to be conducted on**06/06/2021** at the **Students activity centre (SAC)** of NIT Durgapur.

In this regard a google form was also circulated along with the above circular to get the exact headcount of individuals interested for vaccination at pre-determined rates. In this connection, as informed by IQ city Hospital, Durgapur, the amount per dose that needs to be paid directly to them by the individual at the time of vaccination is Rs.950/- only. Further, to maintain social distancing and other CoVID-19 protocols the vaccination shall be done on the basis of the sequence in which the responses were recorded in the google form, therefore all interested individuals with their family members can proceed for vaccination at SAC as per the slot allotted to them. Detailed slot scheduled in attached in the ANNEXURE I.

It is also informed that registration on the CoWIN portal i.e. https://www.cowin.gov.in/ is necessary (if not done yet) for vaccination and all are requested to carry the Mobile and a copy of ID proof used for registration along with them for vaccination. Although on-spot registration shall be available, prior registration is recommended for speedy process.

In continuation to the above, any individual (Permanent Employees their dependent members and Retired Employees) who could not fill the google form and who are interested to get vaccinated are also requested to proceed for vaccination in the **Slot 5 from 04:30 PM onwards.**
