If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempte the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder wants to avail themselves of the Purchase preference, the bidder must be manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Po Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service.
