Salient features of Rules for change of Branch are as follows (UG Regulations Clause No. 3):

1. Only those students will be eligible for consideration for a change of branch after second semester, who have:
 - a. Completed all the subjects as prescribed in the First and Second semester in the first attempt.
 - b. Must have secured a SGPA not less than 9.00 (in both 1st and 2nd semester separately) for General / OBC / EWS and have secured a SGPA not less than 8.50 (in both 1st and 2nd semester separately) for SC / ST.
2. Students may opt for choices of branch, in order of preference, to which they wish to change over. It will not be permissible to alter the choice or withdraw the application after it has been submitted.
3. Change of branch shall be made strictly on the basis of merit of the applicants. For this purpose the CGPA obtained at the end of the Second Semester and JEE (Main) rank (with equal weightage) shall be considered. Ties will be broken by JEE (Main) rank of the applicants concerned.
4. All changes of branch made in accordance with the above rules will be effective from the 3rd Semester. No change of branch shall be permitted thereafter.
5. The number of students in any discipline must not fall below 80% of the number of registered student at 3rd semester of Academic Year 2026-2076 as a result of change of branch.
6. Branch change is possible between similar programs, for example:
 - a. 4-year B. Tech program of one branch to another branch of 4-year B. Tech program.
 - b. 5-year Integrated M.Sc program of one branch to another 5-year Integrated M.Sc program.
 - c. 5-year Dual Degree program of one branch to another 5-year Dual Degree program.

Based on the above, **eligible students** are advised to fill up and submit an online application <https://forms.gle/nc93pYeP4WT745Sz7> for change of branch to be submitted (starting on **05.06.2026 after 4:00 PM**) and latest by **16.06.2026 (12:00 Noon)** with uploading self-attested photocopy of - JEE (Main) Examination Score Card.
