Subject: Revised Hostel Return Schedule for the UG and PG students in a phase-wise manner

By taking the stock of the present COVID situation and the restrictions imposed by different State and National Governments and identification of Omicron in different States of the Country, the 64th Senate held on 24.12.2021 has resolved that the earlier plan of return of the students as notified on 06.12.2021 has been rescheduled as follows:

Vaccination: In order to return to the campus, at least **1st dose of vaccination** for Covid 19 is mandatory. Vaccinated students are requested to bring print-outs of their vaccination certificates. While returning to the campus, you may need to produce them to the security. Institute may arrange for the 2nd dose of vaccination for Covid 19, if required.

Hostel Accommodation: Most of the accommodation in hostels will be provided on a shared basis. Students non-willing to stay in hostels, may be permitted to stay outside and attend the classes as a day scholar for this semester. Such students may approach their wardens for seeking permission to stay outside.

Mess/canteen registration: At the beginning of each semester, student registration is compulsory in the respective canteen/mess according to their allotted hostel.

1. Students (Hall 9, Hall 10, Hall 11, and Hall 13) have to mandatorily collect his/ her minimum 20 food coupons each for breakfast, lunch and dinner in a calendar month on direct payment to the vendors.
2. RT-PCR Negative Report: Irrespective of the vaccination, it has to be carried out by all students, not earlier than the 72 hrs before the return to the campus.
3. Parents/ accompanying persons: At maximum 2 persons may accompany the students. They will be given a short duration entry pass having RT-PCR Negative Report as mentioned in Sl. No. 2 and in no-case they will be allowed to stay inside the campus.

Consent Form: It is a consent form for staying within the campus. Parents should put signature on it understanding the situation and responsibility that they need to shoulder on. NIT Durgapur administration seeks whole-hearted cooperation and support from the learned, honorable parents and our lovable students. Print out of the Annexure – I signed by the students and her/his guardians must be submitted to the hostel manager/care-taker/warden.

Restricted Movements: Students will have restricted movements inside the campus and may not be permitted to go out of the campus. Therefore, they are all requested to bring necessary essential items such as, bucket, mug, soaps, toothpastes, dry fruits etc.
