Individual entitlement and due referral of the Medical Officer of the Medical Unit of the Institute along with two copies of referral letter out of which one copy will contain name, status of the employee etc. as specified in the respective Medical Book shall have to be provided during both Outdoor and Indoor treatment. In the case of dependent family members of the employees, the details should be given as enunciated in the respective Medical Book. In the case of inpatient treatment, patients can visit directly the OPD counter of the said Hospital with valid proof of identity. The cost of treatment for both outpatients and inpatients shall be regulated at the rate of CGHS Kolkata and CS(MA) Rules,1944 or of the between SHRI RAMKRISHNA INSTITUTE OF MEDICAL SCIENCES & SANAKA HOSPITALS, Durgapur, whichever is less.
