## CIRCULAR

- VI. All Faculty members/ Teachers/ Researchers/ Non-Teaching staff and Students including outsourced staff working in NIT Durgapur are requested to download the 'Aarogyasetu' App on their mobile phones immediately and follow the advisory issued by the Ministry of Health and Family Welfare, GOI from time to time.
