**Step 2: Filling and Submission of anti-ragging Affidavit** – Fill the affidavit at [www.amanmovement.org](http://www.amanmovement.org), and take a print.

**Step 3: Submission of anti-drug declaration form** – Fill the anti-drug declaration as attached with this Notice.

**Step 4: Online submission of semester registration form** – This will be active from **mid of January 2024** at Chanakya ERP module ( <http://14.139.221.18:9001/>). Ensure that the subjects that you are studying are rightly coming in the semester registration form. Also, note that mentioning of ABC (Academic Bank of Credit) ID is mandatory during the semester registration form.

**Step 5: Endorsement from the Department** – Submit the print out of semester registration form generated from Chanakya ERP module following Step 4 to the Office of the HoD for necessary endorsement from the HoD / UG Coordinator of the respective Department.

**Step 6: Endorsement from the Hostel** – Kindly submit following documents to the office of Warden of the respective hostel, where you are staying.

- (a) Semester registration form duly signed by you and endorsed by HOD / UG Coordinator of your Dept.
- (b) Print-out of anti-ragging affidavit
- (c) Print-out of anti-drug declaration form.
- (d) Receipt of the Semester registration fee payment
