**Sub: Commencement of Even Semester 2023-2024, Payment of Even Semester 2023-2024 Registration fee of PhD programme and submission of filled semester registration form.**

1. The Even semester 2023-2024 for the PhD programme will commence from 01.01.2024.
2. The research scholars of PhD programme are mandatorily required to pay their respective semester registration fee for even semester 2023-2024 within 30.01.2024.

The concerned students are advised to enter their respective roll numbers in the space marked as "Registration no" at the time of logging in the portal and submit to proceed.

3. Rs. 20/- per day will be charged per student as late fee from 31.01.2024 to 16.02.2024 to be collected with semester registration fee. Online payment portal will not be operational after 16.02.2024.
  4. The research scholars of PhD programme are advised to visit website [www.amanmovement.org](http://www.amanmovement.org) in order to fill up their individual affidavits online.

The exercise of filling up / submission of the affidavits by the individual student are mandatory.

Submission of filled in anti-drug declaration is also mandatory.

Hostel and Mess / Canteen clearance certificate for semester registration is also required to be submitted.

Duly filled / signed original / hard copies of semester registration form with necessary enclosures along with the semester registration payment receipt and print out of anti-ragging affidavits with filled in anti-drug declaration must be submitted to the office of the Dean (Academic Research) through the department by 16.02.2024, failing which the matter will be dealt in accordance with the provisions of the present PhD regulations.
