NOTIFICATION

This is to notify to all Faculty members/Students /Researchers/ Non-Teaching staffs/ Outsourced Staffs of the Institute that in addition to earlier notification issued vide No. NITD/Estt./CoVID-19/2021/4 dated 15/05/2021 regarding the restrictions imposed by Government of West Bengal to contain and combat the spread of CoVID-19 Pandemic vide their order No.647-ISS/2M-22/2020 dated 15/05/2021, further notification have been released by Government of West Bengal vide no. 707-ISS/2M-22/2020 dated 29/02/2021 stating that the aforesaid restriction measures stands extended up to 06:00 PM of 15th June, 2021.

In-order to ensure the safety of Faculty members/Students / Researchers/ Non-Teaching staffs and Outsourced Staffs of Institute, the competent authority has arrived at the following decisions:

- 1. The Institute will remain closed up to 15th June 2021. Unnecessary movement of the residents is to be restricted inside and outside the campus.
- 2. Online classes and examinations shall be taken up as per the academic calendar uploaded on the Institute website.
- 3. Faculty Members/ Researchers/ Non-Teaching staffs and outsourced staffs of Institute are advised to work from home till 15th June 2021. However, they are requested to be available on phone and ready to assist the administration, in case there is a need.
- 4. The employees who stay outside the campus are requested to contact the respective Heads for work related matter on day-to-day basis and are also advised to work from home.
- 5. The essential Services like Institute Health center/ Security/ Civil/ Electrical Maintenance / Water Supply/ Internet/ Telephone/ Cleaning/ Gardening services/ Food Supply to Hostels, Isolation Ward and Patients in Home Isolations etc. shall function as usual.
- 6. Students, who are still in the hostels, particularly the foreign students, are allowed to continue to stay in the Hostels and are advised to take necessary safety precautions.
- 7. All Faculty members/ Students/ Researchers/ Non-Teaching staffs/ outsourced staffs are requested to download the 'Aarogyasetu' App on their mobile phones, immediately and follow the advisory issued by the Ministry of Health and Family Welfare, GOI from time to time.
- 8. All Faculty members/ Teachers/ Researchers/ Non-Teaching staffs and Students are urged to visit Institute Website regularly for any further update.
