

The Rolling Advertisement No.NITD/Estt./02/07/2019 (Rolling) was floated on largely 22.07.2019 in circulated newspapers like Times of India and Ananda Bazar for recruitment of faculty members in different cadres in all academic departments of the Institute. Further, the advertisement No.NITD/Estt./02/07/2019 (Rolling) has been also displayed in the Institute's website. The applications in this regard were taken into account for screening purpose by the cease work of March 12, 2021 at 5.00 p.m. for the fourth phase of Rolling Advertisement. The applications that were received within the closing date were scrutinized meticulously by the respective departments. Interview call letters were emailed to the shortlisted candidates in due time. The selection committees were duly constituted following clause no 12 of "The Gazette of India Extraordinary, Part II – Sec.3(i)". The Interview for the departments of CS, CE & EES were held on 10th, 11th, 12th, 17th, & 18th August 2021.

The lists of the selected candidates in different cadres, viz. Assistant Professor (AGP Rs. 6000/-, AGP Rs. 7000/- and AGP Rs. 8000/-) & Associate Professor (AGP Rs. 9500/-) in different departments are being placed to the BoG for kind perusal and necessary approval for issuance of appointment letter (Annexure – C).

Based on the office order No. NITD/Estt.4p-958/Release Order/2019/Nov, dated 29.11.2019, Dr. Vijay Kumar Dwivedi joined in the Mahanadi Water Dispute Tribunal (MWDT), New Delhi, under the Ministry of Jal Shakti, Govt. of India on 03.12.2019 after being released from the Institute on 30.11.2019 (F/N) the post of **Assessor** on Deputation basis for a period of one-year w.e.f. 03.12.2019. The tenure was further extended from 03.12.2020 to 02.12.2021 following the application received from Dr. Dwivedi.

In light of guideline of Dopt. OM no. 6/8/2009-Estt.(Pay-II) dated 17.06.2010 in respect of tenure of deputation service, it is specifically clarified that the borrowing organization (herein MWDT) may extend the period of deputation upto the seventh year at a stretch in public interest if absolute necessary, subject to the prior approval of the competent authority of the lending organization (herein NITD) keeping all other terms and conditions unchanged covered under OM vide No. 6/8/2009-Estt.(Pay-II) dated 17.06.2010.

In the meeting of the DAC of the Civil Engineering Department held on 20.08.2021, it was noted that the deputation period of Professor V.K. Dwivedi to MWDT has already been extended to two years for which the Institute and students have suffered. At present the department is not in favour of recommending him further extension for the interest of the main stake holders/students.

The conduction of the international conference on **Recent Advances in Molecular Plant – Pathogen Interactions (RAMPPI 2021)** organized by Department of Biotechnology, NIT Durgapur was initially approved by the Director and the Chairperson, Board of Governors. **Subsequently, the** Ministry of Education, Department of Education approved the conduction of the International conference vide its communication No. F. No.5-2/2021-TS.III dated 19 August 2021. (**Annexure – F**)

The final year PG students shall be permitted to return in batches 15 days after the return of the PhD students for a duration of one month to complete their experimental work. Precautionary measures for their stay and work shall be taken by the Institute. Their supervisors shall remain in station and report any illness of a student to the Medical Unit urgently.

Sub: Reservation of posts in direct recruitment for faculty cadre, NIT Durgapur.

Erstwhile MHRD, Govt. of India vide F.No. 33-3/2018-TS.III dated 5th November, 2019 has been issued the directive for implementation of reservation of posts in Teachers' Cadre in direct recruitment out of sanctioned strength. In this regard, the Central Government has published a Notification in the Gazette of India Extraordinary on 12th July, 2019, which provides as under: "The Central Government hereby specifies that there shall be reservation of posts in direct recruitment out of the sanctioned strength in teachers' cadre in a Central Educational Institution in the manner specified in Office Memorandum, No.36039/1/2019-Estt/(Res.) of the Department of Personnel and Training, Ministry of Personnel, Public Grievances and Pensions dated 31st January, 2019 to the extent as follows, namely:-

- (a) Fifteen per cent. For Scheduled Castes;
- (b) Seven and one-half per cent. For Scheduled Tribes;
- (c) Twenty- seven per cent. For socially and educationally backward classes; and
- (d) Ten per cent. For economically weaker sections."

At present the vacant faculty position of the Institute is **71(seventy one)**.

According to above reservation policy,

SC 15% of 71=10.65 rounded off 11,

ST 7.5 %=5.33 rounded off 5,

Socially and Educationally Backward Classes 27%=19.17 rounded off 19

And For Economically Weaker Sections (who are not covered under the scheme of reservation for (SCs, STs and OBCs) 10% of 71=7.1 rounded off 7,

Total 42(Reserved)

Rest (71-42)=29 UR (5% PWD is under reservation with UR).

Resuming the meeting, the Chairman, Senate informed the Senate about the **Centre for Digital Learning** that was inaugurated on August 18, 2021 by Dr. Subhas Sarkar, Hon'ble MoS, MoE, Government of India. He apprised the Senate of the future plans for using the centre to prepare e-learning resources, offering online courses and programs and for social outreach by way of educating rural school students belonging to socio-economically disadvantaged groups (SEDG) through distance education in line with the NEP-2020. The Senate appreciated and endorsed the initiative.

Item No. 61.7 To consider amendments in PG regulations

The Senate approved the amendments in the PG regulations as recommended by the PGAC (Annexure-III). The PGAC will revisit the minimum number of students required to float an elective course. The PGAC will also examine the minimum number of students required to continue a Master's program. It was resolved that a PG student cannot take a UG elective course. However, senior level UG students can opt for PG courses as electives.

To consider revision in the M. Tech curriculum and syllabus The Senate approved the revised Curriculum and Syllabus for the M. Tech. and MBA programs as recommended by the PGAC for its implementation from the academic session 2021-2022.

To consider introducing self-sponsored M. Tech programs The Senate requested the DPACs to explore the possibility of offering self-sponsored, self-financed M. Tech programs. Chairman, Senate was empowered to constitute a committee to formulate the guidelines. The committee and the departments will submit reports to the Dean (AC) for consideration by the PGAC.

PART C: MATTERS RELATED TO PhD STUDIES

Item No. 61.10 To ratify the resolution through circulation by the Senate on revision in the academic qualification criteria for admission to the PhD program

The Senate ratified the resolution through circulation on revision in the academic qualification criteria for admission to the PhD program.

Item No. 61.11 To consider the resolutions of RAC meetings

The Senate approved/ratified the resolutions of the RAC meetings held on 20.7.2021, 29.7.2021, including the award of PhD degrees (Annexure IV) and registration candidates for the PhD program (Annexure V) with the following addendum.

• 29.7.2021: Item#7: To consider the matter regarding discontinuation from the programme

The respective HoDs will interact with the candidates, assess the status with reference to cl. 14.0 of the PhD Regulations and the Senate resolution #51.6(vi), explore possible actions, and finally submit a recommendation to the Dean (AR).

• 29.7.2021: Item#13: To consider the matter of Prasanta Parida (Roll No. 20MA1111 – Category B) regarding his employment in an organization

The Senate approved the termination of studentship of Prasanta Parida (Roll No. 20MA1111), a category-B PhD student of Mathematics department.

Item No. 61.12 To consider amendments in PhD regulations

The Senate approved the amendments in the PhD regulations as recommended by the RAC (Annexure VI). The amended PhD regulations shall be uploaded on the Institute website.

Item No. 61.13 To consider the award of PhD posthumously

The Senate approved the award of PhD posthumously to Late Mamoni Garai (NITD/PhD/CY/2016/00775) and Late Shyamasree Gupta (NITD/PhD/PH/2015/00656).

The Senate also resolved that the Posthumous PhD degree will be awarded to a deceased student only if the formalities up to the receipt of the 'RECOMMENDED' report and possibly with suggestions and comments from both examiners (from India and abroad) are completed and the compliance report is submitted and approved by DSC. Each such case will, however, needs the recommendation of the Senate.

Item No. 61.14 To consider re-introduction of self-sponsored PhD programs

The committee constituted in agenda item # 61.9 will formulate the guidelines for self-sponsored PhD program and submit it to the RAC. The committee will also formulate the guidelines for freelance PhD candidates.

PART D: OTHER MATTERS

Item No. 61.15 To decide the Academic Calendar for the Academic Session 2021-22

The Senate approved the Academic Calendar for the Session 2021-22 (other than first semester UG) as recommended by UGAC and PGAC on 22/07/2021. It was also resolved that all sessional and laboratory classes will continue in online mode. In case the students are able to

return to the campus in due time, hands-on experiments shall be repeated in the laboratories.

Item No. 61.16 To decide the requirements for the return of the remaining PhD and PG final year students to campus

The Senate resolved that the remaining PhD students and the final year PG students shall be permitted to return to campus after taking (i) both COVID vaccines or (ii) one vaccine and a negative RTPCR test report from an ICMR-recognized laboratory. The final year PG students shall be permitted to return in batches 15 days after the return of the PhD students for a duration of one month to complete their experimental work. Precautionary measures for their stay and work shall be taken by the Institute. Their supervisors shall remain in station and report any illness of a student to the Medical Unit urgently.

Item No. 61.17 To consider introduction of a one-credit compulsory course on "The Constitution of India" for all students

The Senate approved the introduction of a one-credit compulsory course on "The Constitution of India" for all first year students. The course may be offered by interested faculty members of all academic departments. The UGAC and PGAC may work out a plan for its implementation from the Academic Year 2021-2022. Pre-recorded courses (such as NPTEL) may also be considered.

Item No. 61.18 To consider signing MoUs with academia, industries and research institutions

The Senate recommended the MoU with TCG-CREST for collaborative PhD program and renewal of MoU with University of Kentucky. The Senate also approved the MoUs with Samsung R&D Institute India-Bangalore Private Limited and AMD India Private Limited.

Item No. 61.19 Any other matter with the permission of the chair

Item No. 61.19.1 To consider grant of earned leave in lieu of vacation to the faculty members

The Senate resolved that in view of the pandemic, no vacation will be made admissible to the faculty members in the calendar year 2021, and 30 days of earned leave will be granted to them in lieu of vacation like last year.

Item No. 61.19.2 To name the Central Library after a distinguished personality

The Senate members were requested to suggest to the Chairman, Senate the name of distinguished personalities after whom the Central Library may be named.

The meeting ended with a vote of thanks to the chair.

Amendments in the UG regulations

Change of branch after first year of UG program [UGAC meeting on 22/07/2021, Item #3]:

The following norms shall be applicable for the students to be admitted from the year 2021-22 onwards.

- Only those student will be eligible for consideration for a change of branch after second semester, who have:
 - a) Completed all the course(s) prescribed in the First & Second semester in the first attempt.
 - b) Have secured a SGPA not less than 9.00 (in both 1st and 2nd semester separately) for General / OBC / EWS and have secured a SGPA not less than 8.50 (in both 1st and 2nd semester separately) for SC / ST.
- The number of students in any discipline must not fall below 80% of the number of registered students at 3rd Semester as a result of change of branch.
- Branch change is possible between similar programs, for example:
 - a) 4-Year B.Tech. program of one branch to another branch of 4-Year B. Tech. Program
 - b) 5-Year Integrated M.Sc. program of one branch to another 5-Year Integrated M.Sc. program
 - c) 5-Year Dual Degree program of one branch to another branch of 5-Year Dual Degree program

Back-log in sessional courses [UGAC meeting on 22/07/2021, Item #4]:

- UG Clause 12.10 shall be deleted.
- UG Clause 12.11 shall be re-written as "A student fail in multiple sessional/laboratory course(s), s/he has to repeat the semester and need to study the courses offered by the department/center for the next batch of students. In case of any repetition of the course(s), the Head of the Department may prescribe a suitably relevant alternate course for the student. However, if a student fail in only one sessional / laboratory course in a semester, s/he may be promoted to the next semester and shall be given an opportunity to complete the course in subsequent semesters as a Backlog sessional subject"

SGPA and CGPA Calculations, if any student is having Supplementary / Back-log [UGAC meeting on 22/07/2021, Item #5]:

The Senate approved the matter as recommended by UGAC.

Transfer of credits [UGAC meeting on 22/07/2021: Item #6]:

- Presently transfer of credits will be considered for UG programs only.
- Maximum transfer of credits by any student from the courses of SWAYAM / NPTEL / E-PATHSHALA / COURSERA, etc. shall be 24.
- Credits earned through those subjects will be used for SGPA / CGPA computations and credits as assigned by the department will be considered.
- Students with consistent academic performance and CGPA ≥ 8.0 can take courses from of SWAYAM / NPTEL / E-PATHSHALA / COURSERA, etc. for credit transfer and has to be approved by the concerned Departmental Academic Committee during 3rd and 4th year and during summer breaks.
- Credits transfer can be considered only for the courses at same level i.e UG, PG etc.

- A student must provide all details (original or self-attested authentic copies or downloaded from authentic websites) such as course contents, number of contact hours, and evaluation system for the course for which s/he is requesting a credits transfer. These details will be evaluated by the concerned departmental academic committees (DAC) before giving approval. These academic committees will then decide the number of equivalent credits the student will get for such course(s) in NIT Durgapur. The complete details will then be forwarded to Dean (Academic Courses) for approval.
- A students has to get minimum passing grades/ marks for such courses for which the credits transfer are to be made.

Dual Degree and Integrated M.Sc. programs (UG Regulation Clause No. #13.5) [UGAC meeting on 22/07/2021: Item #8]:

UGAC will revisit the calculation of CGPA for the second degree for dual degree program. Interim exit option of the students was not turned down by the Senate. Rest of the points as recommended by UGAC were approved.

Modification in Grade card Layout and issuance of consolidated Grade card during graduation [UGAC meeting on 22/07/2021, Item #9]:

The Senate approved the matter as recommended by UGAC. The consolidated grade- card will be signed by Dean (Academic Courses). However, all grade cards will be signed by Joint Registrar (A&E).

Evaluation mechanism of courses having Lecture and practical components (e.g., 3-0-2, 2-0-3, 3-0-3 etc.) [UGAC meeting on 16/08/2021, Item #5]:

- a) For Assessing the performance of students, following weights will be considered "Continuous Assessment 10%, Midterm Examination 20%, End-term examination 40%, Laboratory evaluation 30%"
- b) Pass marks for the lab will be 15 and pass marks for the theory part (summation of CA, Mid-term and end-term examination) will be 25. A student failing in any part (either theory / lab) will be awarded "F" grade, however, they will have to clear only the corresponding part in subsequent supplementary / back-log examinations.

Introduction of Minor

The curriculum will be uploaded on the Institute website. The detailed syllabus will be uploaded by the concerned department in the departmental page of the Institute website. Following points shall be incorporated in the UG regulations:

- (a) New Courses wherever possible, will have open elective codes so as to have more flexibility
- (b) Allocation of students in different minor programs will be made centrally based on the choices given by the students before the start of the 4th Semester and once a Minor Program is allotted to a student, he/she may opt out from the program, however, changeover to any other minor programs is not possible.
- (c) Students having CGPA of more than or equal to 8.5 at the end of 3rd Semester are only eligible to apply.
- (d) Minimum number of students required to float a minor program is 5, whereas, individual programs may have different maximum limit as mentioned in the table below.
- (e) A student cannot take more than 8 credits in a semester for Minor program.
- (f) Separate SGPA and CGPA calculations will be given for Major programs and Programs including Minor courses. Minor courses will be separately indicated in Grade Card.
- (g) Degree Nomenclature will be different from the existing one. In those cases where the student has earned the required credits for a Minor in another discipline within the stipulated time, this will be mentioned in the degree certificate as:
- B.Tech. in Chemical Engineering with Minor in Electrical Engineering
- B.Tech. in Chemical Engineering (under Dual Degree program) with Minor in Electrical Engineering

However, if a student fail in only one sessional / laboratory course in a semester, s/he may be promoted to the next semester and shall be given an opportunity to complete the course in subsequent semesters as a Backlog sessional subject"

SGPA and CGPA Calculations, if any student is having Supplementary / Back-log [PGAC meeting on 22/07/2021, Item #5]:

The Senate approved the matter as recommended by PGAC.

Modification in Grade card Layout and issuance of consolidated Grade card during graduation [PGAC meeting on 22/07/2021, Item #9]:

The matter was approved as recommended by PGAC. The consolidated grade card will be signed by Dean (academic courses), however, all grade cards will be signed by Joint Registrar (A&E).

Evaluation mechanism of courses having Lecture and practical components (e.g., 3-0-2, 2-0-3, 3-0-3 etc.) [PGAC meeting on 16/08/2021, Item #5]:

- a) For assessing the performance of students, following weights will be considered "Continuous Assessment 10%, Midterm Examination 20%, End-term examination 40%, Laboratory evaluation 30%"
- b) Pass marks for the lab will be 15 and pass marks for the theory part (summation of CA, Mid-term and end-term examination) will be 25. A student failing in any part (either theory / lab) will be awarded "F" grade, however, they will have to clear only the corresponding part in subsequent supplementary / back-log examinations.

OFFICE MEMORANDUM

Subject: Transfer on deputation/foreign service of Central Government Employees to excadre posts under the Central Government/ State Governments/Public Sector Undertakings/Autonomous Bodies, Universities/ UT Administration, Local Bodies etc. and vice-versa – Regulation of pay, Deputation (duty) Allowance, tenure of deputation/ foreign service and other terms and conditions – regarding.

The undersigned is directed to refer to this Department's O.M. No.2/29/91-Estt. (Pay II) dated 5th January, 1994 as amended/revised from time to time. A need has been felt to consolidate all these orders in one place and accordingly, it has been decided, in consultation with Department of Expenditure, to bring out a self contained O.M. in supersession of OM dated 5.1.94 and subsequent amendments on the subject, incorporating the provisions of earlier orders with suitable modifications, wherever necessary.

2. Application

- 2.1 These orders will apply to all Central Government employees, who are regularly appointed on deputation/foreign service in accordance with Recruitment Rules of the excadre posts, under the same or some other Departments of Central Government or under the State Governments/ Union Territories Administration/ Local Bodies or under Central/State PSUs/Autonomous Bodies etc. set up or controlled by Central/State Governments provided the foreign service under such PSUs/autonomous bodies has been permitted in relaxation of appointment on immediate absorption basis. These orders will also cover the cases of regular appointment on deputation/foreign service of employees of State Government/local bodies etc. as well as PSUs/Autonomous Bodies of Central/State Governments as per recruitment rules in the Central Government.
 - 2.2 However, the following cases shall not be covered under these orders for whom separate orders exist:-
 - (a) Members of the All India Services and those deputed to posts, whose terms are regulated under specific statutory rules or orders;
 - (b) Officers appointed on deputation to posts under the Central Staffing Scheme (CSS) for whom separate orders as issued from time to time will continue to apply;
 - (c) Deputation to posts operated outside India;

- Appointments of a specific category of employees to a specified class of posts, such as appointments made in the Personal Staff of Ministers etc., in respect of which special orders are already in existence. However, the terms and conditions set out in this O.M. will apply to those cases to the extent these are not specifically covered under such special orders.
 - Appointments of the nature of deemed deputation or transfers to ex-cadre posts made in exigencies of service with the specific condition that no deputation (duty) allowance will be admissible - e.g. (i) interim arrangements in the event of conversion of a Government office/organisation or a portion thereof into a PSU/ autonomous body or vice-versa; and (ii) appointments to the same post in another cadre.
 - Scope of Term 'deputation/ foreign service' Restrictions on treating an appointment 3. as on deputation/ foreign service.
 - The terms deputation/foreign service will cover only those appointments that are made by transfer on a temporary basis provided the transfer is outside the normal field of deployment and is in public interest. The question whether the transfer is outside the normal field of deployment or not will be decided by the authority which controls the service or post from which the employee is transferred.
 - The following types of appointments will not be treated as deputation/foreign service 3.2 for the purposes of these orders:
 - (a) appointment of serving employees made either by promotion or by direct recruitment from amongst open market candidates whether on permanent or temporary basis.
 - (b) permanent appointment made by transfer.
 - (c)Temporary appointment made on the basis of personal requests of employees.
 - (d) Arrangements necessitated by staff imbalances arising on re-organisation of offices on the same or different stations, subject to the specific condition that no deputation (duty) allowance will be admissible in such cases.
 - A person in a higher Grade Pay/scale of pay shall not be appointed on deputation to a post in lower Grade Pay/scale of pay if the deputation is from Central Government to Central Government and also in cases where the scale of pay and dearness allowance in the parent cadre post and ex-cadre post are similar.
 - However, no appointment on deputation/foreign service shall be made from/to Central Government/ an organisation where the pay scale and DA in the parent cadre post and ex-cadre post are dissimilar, if the basic pay in the parent cadre increased by one increment plus dearness allowance(s) including interim relief if any, admissible to a person in the parent cadre post exceeds the basic pay plus dearness allowance (s) including interim relief, if any, at the maximum of the pay scale of the ex-cadre post. In the revised pay structure, the maximum of the scale would mean the sum of the Grade Pay of the ex-cadre post and maximum of the Pay Band PB 4 i.e. Rs. 67000. For example, if the ex-cadre post

is in the Grade Pay of Rs. 4200, then the maximum would be Rs. 71200 i.e. Rs. 4200 plus Rs. 67000 (maximum of PB 4).

Exercise of option

- 4.1 An employee appointed on deputation/foreign service, may elect to draw either the pay in the scale of pay of deputation/foreign service post or his/her basic pay in the parent cadre plus deputation (duty) allowance thereon plus personal pay, if any. However, in case of Government employees on deputation/ foreign service to CPSEs, this option will not be allowed and their pay will be governed in terms of the orders issued by Department of Public Enterprises vide OM dated 26.11.2008 and clarifications issued thereafter.
- 4.2 The borrowing authority shall obtain the option of the employee within one month from the date of joining the ex-cadre post unless the employee has himself furnished the option.
- 4.3 The option once exercised shall be final.
- 4.4 However, the employee may revise the option under the following circumstances which will be effective from the date of occurrence of the same:
- (a) When he/she receives proforma promotion or is appointed to non-functional selection grade or up-gradation of scale in the parent cadre;
- (b) When he/she is reverted to a lower grade in the parent cadre;
- (c) When the scale of pay of the parent post on the basis of which his emoluments are regulated during deputation/foreign service or of the ex-cadre post held by the employee on deputation/foreign service is revised either prospectively or from a retrospective date.
- (d) Based on the revised/same option of the employee, in the event of proformal promotion/appointment to non-functional Selection Grade/revision/upgradation of scales of pay in the parent cadre, his/her pay will be re-fixed with reference to the revised entitlement of pay in the parent cadre. However, if the initial option was for the pay scale of the deputation post and no change in option already exercised is envisaged, the pay already drawn in deputation post will be protected if the pay refixed is less.

Note: Revision in the rates of DA, HRA or any other allowance either in the parent or borrowing organisation shall not be an occasion for revision of the earlier option.

4.5. If the pay of an employee in his cadre post undergoes downward revision, the pay in the ex-cadre post is also liable to be re-fixed on the basis of revised pay and in accordance with the revised option or existing option if the employee does not revise his option.

5. Pay fixation

5.1 When an employee on deputation/Foreign Service elects to draw pay in the scale of pay attached to the ex-cadre post, his/ her pay may be fixed as under:

(i) <u>Deputation from Central Government to Central Government</u>

If the scale of pay/Grade Pay of the ex-cadre post is higher, the pay may be fixed after adding one increment to the existing pay in the Pay Band of the parent cadre post. The grade pay corresponding to the ex-cadre post would thereafter be granted in addition to this pay in the pay band. However, in cases where the fixation of pay in the ex-cadre post involves change of Pay Band also, if the pay in the pay band after adding the increment is less than the minimum of the pay band corresponding to the grade pay of the ex-cadre post, the pay in the pay band will be fixed at the minimum of the Pay Band.

In case the Grade Pay/scale of employee's cadre post and the ex-cadre post are identical, the employee would continue to draw his/her existing basic pay.

In case the Grade pay of the ex-cadre post is upto Rs 10000, the Basic Pay, from time to time after pay fixation should not exceed the maximum of the pay band PB-4 (Rs.67000) plus the grade pay of the post held on deputation. In case the ex-cadre post is in the HAG or HAG+ pay scale, the Basic Pay, from time to time after pay fixation should not exceed Rs. 79000 or Rs.80000 respectively.

(ii) In foreign servi¢e/ Reverse Foreign Service

- (a) when the pay scale of the post in the parent cadre and that attached to ex-cadre post are based on the same index level and the DA pattern is also same, the pay may be fixed as under (i) above.
- (b) If the appointment is made to a post whose pay structure and/ or DA pattern is dissimilar to that in the parent organisation, pay may be fixed by adding one increment to the pay in the parent cadre post in the scale of his regular parent post (and if he/she was drawing pay at the maximum of the scale, by the increment last drawn) and equating the pay so raised plus dearness allowance (and additional or ad-hoc dearness allowance, Interim relief etc., if any) with emoluments comprising of pay plus DA, ADA, Interim relief etc., if any, admissible, in the borrowing organisation and the pay may be fixed at the stage in the pay scale of the ex-cadre post at which total emoluments admissible in the ex-cadre post as above equal the emoluments drawn in the cadre.
- 5.2 In cases of appointment from one ex-cadre post to another ex-cadre post where the employee opts to draw pay in the scale of the ex-cadre post, the pay in the second or subsequent ex-cadre post should be fixed under the normal rules with reference to the pay in the cadre post only. However, in respect of appointments to ex-cadre posts carrying Grade Pay identical to that of the ex-cadre post(s) held on an earlier occasion(s), it may be ensured that the pay drawn in subsequent appointment should not be less than the pay drawn earlier.

In cases of appointments to a second or subsequent ex-cadre post(s) in a higher pay scale/grade pay than that of the previous ex-cadre post, the pay may be fixed with reference to the pay drawn in the cadre post and if the pay so fixed happens to be less than the pay drawn in the previous ex-cadre post, the difference may be allowed as personal pay to be absorbed in future increases in pay. This is subject to the condition that on both the occasions, the employee should have opted to draw pay in the scales of pay/Grade Pay attached to the ex-cadre posts.

Note-1: The term parent post and basic pay means the post held on regular basis in the parent organisation and pay drawn/ admissible in such a post respectively.

An officer who may be holding a higher post on adhoc basis in the cadre at the time of proceeding on deputation/ foreign service would be considered to have vacated the post held on adhoc basis and proceeded on deputation/ foreign service from his/her regular post. During the period of deputation/ foreign service, he/she shall earn notional increments in the parent cadre post. On reversion, if he/she is re-appointed to the higher post on regular or adhoc basis his pay will get fixed with reference to the pay admissible in the lower post on the date of such re-appointment. In such cases, if his pay gets fixed at a stage lower than that of his junior(s) who continued to serve in the cadre, no stepping up will be admissible as per extant rules in so far as Central Government employees are concerned. However, if the pay so fixed is less than the pay drawn earlier while holding the post on ad-hoc basis the pay earlier drawn will be protected. Therefore, those Central Government employees who are already holding a higher post on ad-hoc basis or expecting it shortly in the parent cadre may weigh all relevant considerations before opting for deputation/foreign service. This note of caution will be applicable to employees of other organisations wishing to apply for posts on deputation in Central Government, if governed by similar rules in parent organisation.

Note-3: Pay of an officer appointed on deputation/foreign service on adhoc basis pending selection of a regular incumbent may also be regulated in accordance with provisions of Para 5.1 & 6.1 of this O.M.

Note-4: The provisions of this Para as well as Para 6 will not apply to appointments on Personal Staff of Ministers. Such appointments will be regulated by separate specific orders issued by the Government in that behalf.

Deputation (duty) Allowance

- 6.1 The deputation (duty) allowance admissible shall be at the following rates:
- (a) In case of deputation within the same station, the allowance will be paid at the rate of 5% of basic pay subject to a maximum of Rs.2000 p.m.; and
- (b) In other cases, Deputation (Duty) Allowance will be payable at the rate of 10% of the employee's basic pay subject to a maximum of Rs.4000/- p.m.

(c) The deputation (duty) allowance as above shall further be restricted as under:-

Basic Pay, from time to time, plus Deputation (Duty) Allowance shall not exceed the maximum of the pay band PB-4 (Rs.67000) plus the grade pay of the post held on deputation in case the Grade Pay of the post held on deputation is upto Rs 10000. In case the post held on deputation is in the HAG or HAG+ pay scales, the Basic Pay, from time to time, plus Deputation (Duty) Allowance should not exceed Rs. 79000 and Rs.80000 respectively.

Note: Basic Pay in the revised pay structure means the pay drawn in the prescribed pay band plus the applicable grade pay but does not include any other type of pay like special pay/allowance etc.

The rates of deputation (duty) allowance as above shall take effect from 1.9.2008.

Note: 1 The term 'same station' for the purpose will be determined with reference to the station where the person was on duty before proceeding on deputation.

- Note: 2 Where there is no change in the headquarters with reference to the last post held, the transfer should be treated as within the same station and when there is change in headquarters it would be treated as not in the same station. So far as places falling within the same urban agglomeration of the old headquarters are concerned, they would be treated as transfer within the same station.
- 6.2 Special rates of deputation (duty) allowance may be admissible under separate orders in any particular area on account of the condition of living there being particularly ardous or unattractive. Where special rate is more favourable than that given in Para 6.1 above, employees deputed to the area will be given the benefit of the special rate.
- 6.3.1 If an employee with the permission of the competent authority, proceeds on deputation/foreign service from one ex-cadre post to another ex-cadre post in the same or another organisation without reverting to his parent cadre, and if the second ex-cadre post is at the same station as the first one, the rate of deputation (duty) allowance would remain unchanged.
- 6.3.2 In cases where a person on deputation/foreign service is transferred by the borrowing authority from one station to another without any change in the post held by him, the rate of deputation (duty) allowance will be refixed as per 6.1 (b).
- 7. Admissibility of pay, allowances & benefits while on deputation/foreign service
- 7.1 Any project allowance admissible in a project area in the borrowing organisation may be drawn in addition to deputation (duty) allowance.
- 7.2 Any special allowance granted to an employee in the parent Department under FR 9(25) or a corresponding rule of parent organisation should not be allowed in addition to deputation (duty) allowance. However, the borrowing department may allow in addition to deputation (duty) allowance, under special circumstances, any special allowance attached to

the post held by the employee in his/her parent Department, by suitably restricting the deputation (duty) allowance. This will require the specific and prior approval of Department of Personnel & Training.

- 7.3 In case special allowance is attached to the scale of pay of the ex-cadre post and the employee has opted to draw pay in that scale, then, in addition to the pay in that scale, he will also be entitled to draw such special allowance. However, such special allowance will not be admissible if he has opted to draw pay in the parent cadre scale/grade pay plus deputation (duty) allowance.
- 7.4 Personal pay, if any, drawn by an employee in his parent department will continue to be admissible on deputation/foreign service if he/she opts to draw pay in the parent cadre scale/grade pay plus deputation (duty) allowance. No deputation (duty) allowance on this personal pay will however, be admissible.
- 7.5 Increments The employee will draw increment in the parent cadre grade or in the scale of pay /grade pay attached to the deputation post as the case may be, depending on whether he has opted for the parent cadre pay plus deputation (duty) allowance or the pay scale /grade pay of the deputation post. If he has opted for pay scale/grade pay of the deputation post, notional increments shall also continue to accrue to him in the post held on regular basis in the parent cadre/ organisation for the purpose of regulation of pay on repatriation to the parent post at the end of the tenure.
- 7.6 Admissibility of allowances and benefits while on deputation/ foreign service.
- (a) Such allowances as are not admissible to regular employees of corresponding status in the borrowing organisation shall not be admissible to the officer on deputation/foreign service, even if they were admissible in the parent organisation.
- (b) Following allowances will be regulated with mutual consent of the lending and borrowing organisation:
- (i) HRA/Transport Allowance
- (ii) Joining time and Joining Time Pay.
- (iii) Travelling Allowances and Transfer T.A.
- (iv) Children Education Allowance.
- (v) LTC.
- (c) Following allowances/facilities will be regulated in accordance with the rules as explained against each:
- (i) Dearness Allowance The employee shall be entitled to dearness allowance at the rates prevailing in the borrowing organisation or in the lending organisation depending on whether he has opted to draw pay in the pay scale/grade pay of the ex-cadre post or the parent grade plus deputation (duty) allowance.
- (ii) Medical Facilities This will be regulated in accordance with the rules of the borrowing organisation.

(iii) Leave – An officer on deputation/foreign service shall be regulated by the Leave Rules of the parent organisation. If however an employee proceeds from vacation department to non-vacation department, or vice-versa, he shall be governed by Leave Rules of the borrowing organisation. At the time of reversion from the deputation post to the parent cadre, the borrowing organisation may allow him/her leave not exceeding two months. The employee should apply for further leave to his Cadre Controlling Authority.

7.7 Leave salary/Pension/NPS Contribution.

- (i) As at present, allocation of leave salary and pension contribution between different Ministries/Departments of Central Government and between Central and State Government has been dispensed with. In such cases of deputation from Central Government to State Government and vice-versa, liability for bearing leave salary vests with the Department from which the officer proceeds on leave or which sanctioned leave and no contributions are payable to the lending drganisation. Liability for pension/ employee's contribution to CPF will be borne by the parent department, to which the officer permanently belongs at the time of retirement and no proportionate contribution will be recovered.
- (ii) In case of deputation of Central Government employees on foreign service terms to Central Public Sector Undertakings/ State Public Sector Undertakings and Autonomous Bodies/ etc., leave salary contribution (except for the period of leave availed of on foreign service) and pension contribution/CPF (Employer's share) contribution are required to be paid either by the employee himself or by the borrowing organisation to the Central Government.
- (iii) In cases of reverse deputation from Central Public Sector Undertakings/ State Public Sector Undertakings/ Autonomous Bodies/local bodies to Central Government, the question regarding leave salary and pension contribution will be decided by mutual consent.
- (iv) In case of employees covered under New Pension Scheme (NPS), the borrowing department shall make matching contribution to the NPS account of the employee.

Tenure of deputation/foreign service.

- 8.1 The period of deputation/foreign service shall be as per the Recruitment Rules of the ex-cadre post or 3 years in case no tenure regulations exist for the ex-cadre post.
- 8.2. In case where the period of deputation/foreign service prescribed in the recruitment rules of the ex-cadre post is 3 years or less, the Administrative Ministry/borrowing organisation may grant extension upto the 4th year after obtaining orders of their Secretary (in the Central Government)/Chief Secretary (in the State Government)/ equivalent officer (in respect of other cases) and for the fifth year with the approval of the Minister of the borrowing Ministry/Department and in respect of other organisations with the approval of the Minister of the borrowing Ministry/Department with which they are administratively concerned.

- 8.3.1 The borrowing Ministries/Departments/Organisations may extend the period of deputation upto the fifth year where absolutely necessary in public interest, subject to the following conditions:
- (i) The extension would be subject to the prior approval of the lending organisation, the consent of the official concerned and wherever necessary, the approval of the UPSC/ State Public Service Commission and Appointment Committee of Cabinet (ACC).
- (ii) If the borrowing organisation wishes to retain an officer beyond the prescribed tenure, it shall initiate action for seeking concurrence of lending organisation, individual concerned etc. six months before the date of expiry of tenure. In no case it should retain an official beyond the sanctioned term unless prior approval of the competent authority to grant further extension has been obtained.
- (iii) No further extension beyond the fifth year shall be considered.
- 8.3.2 Where extension is granted up to the fifth year, the official concerned will continue to be allowed deputation (duty) allowance, if he/she has opted to draw deputation (duty) allowance.
- 8.4 There shall be a mandatory 'cooling off' period of three years after every period of deputation/foreign service up to Joint Secretary level posts and one year for Additional Secretary level posts.
- 8.5 A Central Government employee shall be eligible for deputation/foreign service to posts in State Government/ State Government Organisations/Government of UTs/ Government of UT's Organisations/ Autonomous Bodies, Trusts, Societies, PSUs etc. not controlled by the Central Government only after he has completed 9 years of service and is clear from the vigilance angle.
- 8.6 If during the period of deputation/ foreign service, on account of proforma promotion in the parent cadre the official concerned becomes entitled to a higher Pay Scale/ Pay Band & Grade Pay in the parent cadre vis-a-vis that of the ex-cadre post, the official shall complete his/her normal /extended tenure of deputation already sanctioned with the approval of the competent authority. The pay shall be regulated as under:
- (a) If the Grade pay of the officer in the parent cadre becomes higher than that of the deputation post after getting proforma promotion, he may be allowed the pay in the pay band + Grade Pay of the post to which he is promoted till the time he completes the normal/extended period of deputation (if he gets proforma promotion in the extended period) already sanctioned, if he so opts. No extension in the period of deputation shall be allowed to him after completing the sanctioned period of deputation.
- (b) If he draws the pay in the pay band + Grade pay attached to the deputation post, on reversion to his parent cadre, his pay may be fixed by allowing him notional increments in his regular post in the parent department + the Grade pay attached to it.

(c) If the Grade pay of the officer in the parent cadre becomes higher than that of the putation post on getting financial upgradation under the ACP/MACP scheme, the officer may be allowed to draw the pay in the pay band + Grade Pay to which he becomes entitled to under the ACP/MACPS, if opted for by him, as laid down in Para 27 of Annexure I to the DOPT OM No. 35034/3/2008 -Estt. (D) dated 19th May, 2009.

Premature reversion of deputationist to parent cadre.

Normally, when an employee is appointed on deputation/ foreign service, his services are placed at the disposal of the parent Ministry/ Department at the end of the tenure. However, as and when a situation arises for premature reversion to the parent cadre of the deputationist, his services could be so returned after giving an advance notice of at least three months to the lending Ministry/ Department and the employee concerned.

Relaxation of conditions.

Any relaxation of these terms and conditions will require the <u>prior concurrence</u> of the Department of Personnel & training.

11. Date of Effect

These orders will take effect from 1.1.2006 and shall be applicable to all officers who were on deputation on 1.1.2006 or appointed thereafter except for the revised rates of deputation (duty) allowarize which shall be applicable from 1.9.2008 as mentioned below Para 6.1 of this OM.

- 12. In so far as persons serving in the Indian Audit and Accounts Department are concerned, these orders will apply for deputation outside Indian Audit and Accounts Department as concurred in by the Comptroller and Auditor General of India.

Subject:

Delegation of powers to Ministries / Departments/Borrowing Organisations to extend deputation tenure upto 7 years in cases of Deputations covered by DoP&T's OM No. 6/8/2009-Estt.(Pay-II) dated 17th June 2010 - regarding.

This Department's OM No. 6/8/2009-Estt.(Pay-II) dated 17th June 2010 regulates Pay, Deputation (Duty) Allowance, Tenure of Deputation / Foreign Service and other terms and conditions on the subject of deputation / foreign service of Central Government employees to ex-cadre posts under the Central Government, State Governments, Public Sector Undertakings, Autonomous Bodies, Universities/ Union Territories Administration, Local Bodies etc. and vice-versa (copy enclosed). Subject to its applicability as provided in para 2 of the OM, these instructions cover cases of deputation/ foreign service where Central Government is either lending authority or borrowing authority or both. It provides for duration of maximum Deputation Tenure as 5 years at a stretch. As per para 8.3.1 (iii) of this OM, no further extension beyond the fifth year shall be considered.

- 2. Various administrative Ministries/ Departments/ Borrowing Organisations have been approaching this Department for relaxation of the 5 year deputation tenure condition, on case to case basis, citing exigencies, quoting provisions of para 10 of the OM dated 17.6.2010 *ibid*.
- 3. It has been decided that if the administrative Ministries / Departments and other borrowing organizations wish to retain an officer beyond 5 years, they may extend tenure of deputation covered by OM No. 6/8/2009-Estt.(Pay-II) dated 17th June 2010, where absolutely necessary in public interest, upto a period not exceeding 7 years at a stretch. This shall be done with the approval of the Minister of the borrowing Ministry / Department concerned and in respect of other organizations with the approval of the Minister of the borrowing Ministry/Department with which they are administratively concerned, keeping in view the exigencies and subject to fulfillment of all other requirements such as willingness and vigilance clearance of the Officer concerned, NOC of the lending authority, UPSC / ACC approval wherever applicable. Thus, no case of extension shall be referred to Department of Personnel & Training, New Delhi.
- 4. All other terms and conditions issued vide OM No. 6/8/2009-Estt.(Pay-II) dated 17th June 2010 will remain unchanged.

- In cases where the necessity to have deputation tenures longer than seven years is felt, the concerned administrative Ministries / Departments/ borrowing organisations may amend the relevant Recruitment Rules of such deputation post accordingly, after following the requisite procedure. No extension of deputation beyond 7 years is to be allowed unless provided in the relevant Recruitment Rules of such deputation post. It is reiterated that no case for extension beyond five years shall be referred to DoPT.
- It is also clarified that cases which are not covered by the OM dated 17.6.2010 including those where Central Government is neither lending authority nor borrowing authority, will continue to be decided in terms of the relevant provisions/ rules/ instructions etc. governing them.
- 7. These orders shall come into effect from the date of issue of this OM.

In its order No. 34-4/2020-ICC-II dated 15.01.2021, the Ministry of Education communicated that all international seminar/symposia/webinars proposed to be conducted should be cleared by the Ministry. In a similar instance in February, 2021, and when informed about the conduction of another international webinar, the Ministry, vide its letter No:F.No.5-2/2021-TS. III, dated 10/02/2021 raised three queries, namely, (1) Whether the approval of BOG has been taken for conducting the said programme; (2) information about the detailed financial implication for the said conference and the source of expenditure to be incurred and (3) the list of the foreign participants and delegates, along with the name of their country who are supposed to attend the said programme.

It may be mentioned in this context that the last meeting of the BoG of NIT Durgapur was held in the online mode on June 20, 2021, and as there was no specific mention in the requirement of BoG concurrence in earlier occasions, the BoG approval was not sought for the conduction of the Webinar. It should also be mentioned in this context that as no meeting of the BoG was held after the issuance of the aforementioned Government order, the requisite permission for the conduction of the proposed International Seminar could not be sought from the Board of Governors.

Under the circumstances, the undersigned seeks the approval of the Chairperson, Board of Governors, NIT Durgapur for the conduction of the Webinar, which approval would may be ratified in the forthcoming meeting of the BoG.
