# Subject: Hostel Return by the Under Graduate (Except 1<sup>st</sup> Yr) and Post Graduate students in a phase-wise manner and off-line / on-line classes.

After detailed deliberations in the Senate, a schedule as available in **Annexure** – **I** has been finalized. During deliberations, feasibility and facility available in the campus were given priority. The second year UG students and first year PG students, the new entrants to the campus, will be allotted a hostel for the first time and need to verify their academic documents. Other all students will be returning to the same hostel and staying in already allotted rooms for the upcoming even semester so as to minimize the initial shifting. It is going to be a tough and testing time for all of us, cooperation from all students, guardians are necessary. The schedule may change depending on exigency occurring/government notification/restrictions imposed thereof.

#### Some useful points/tips:

- 1. **Conduct of off-line classes:** Even semester classes for all UG programs will be off-line as was the practice in the pre-Covid period and course materials will be uploaded on-line as is the practice now. Since, final year students are permitted to under-go full semester (8<sup>th</sup> semester for B. Tech. program) industry internship and therefore, they may study compensatory subjects through on-line mode (from SWAYAM, NPTEL etc.). To facilitate this, NIT Durgapur is also trying to float some of the subjects on-line. This process related to final year students requires some time since NIT Durgapur is exercising it for the first-time. Therefore, initial couple of weeks, all classes for the final year students will be held online.
- Vaccination: In order to return to the campus, at least 1<sup>st</sup> dose of vaccination for Covid 19 is mandatory. Vaccinated students are requested to bring print-outs of their vaccination certificates. While returning to the campus, you may need to produce them to the security. Institute may arrange for the 2<sup>nd</sup> dose of vaccination for Covid 19, if required.
- 3. **RT-PCR Negative Report:** Irrespective of the vaccination, it has to be carried out by all students, not earlier than the 72 hrs before the return to the campus.

- Parents/ accompanying persons: At maximum 2 persons may accompany the students. They will be given a short duration entry pass having RT-PCR Negative Report as mentioned in Sl. No. 2 and in no-case they will be allowed to stay inside the campus.
- 5. Consent Form: It is a consent form for attending classes off-line and stay within the campus. Parents/Guardians shall put signature on it understanding the situation and responsibility that they need to shoulder on. NIT Durgapur administration seeks whole-hearted cooperation and support from the learned, honorable parents and our lovable students. Print out of the Annexure – II signed by the students and her/his Parents/Guardians must be submitted to the hostel manager/care-taker/warden.
- 6. **Restricted Movements:** Students will have restricted movements inside the campus and may not be permitted to go out of the campus. Therefore, they are all requested to bring necessary essential items such as, bucket, mug, soaps, toothpastes, dry fruits, Basic medicines etc.
- 7. Separate notification will be issued from the individual hostel regarding the mess fee/canteen fee and hostel caution money.
