Research has always been a focus area for National Institute of Technology, Durgapur with the faculty members and the students engaged in quality research in various domains. The same is reflected in the large number of publications and citations in premier journals of the world. This has also helped the Institute jump from 47th to 29th in the NIRF (Engineering). The Institute has recruited very energetic young faculty members in recent times with more faculty members likely to join soon in the ongoing recruitment drive.

The exiting sanctioned annual intake of only 75 PhD seats has become highly inadequate to support and sustain the research activities spearheaded by the faculty members in the Institute. It may also be noted that NIT Durgapur, in keeping with the NEP-2020, has planned to initiate more research in areas of direct societal impact, which will need an urgent increase in the sanctioned PhD seats.

Accordingly, it is proposed to kindly consider the sanction of 25 additional PhD seats to the Institute to help it embark upon a higher research trajectory. An additional fund of Rs. 1 crore (25 x Rs.4 lakhs) will be required for their fellowship under the head Oh-31.

Dear Sir,

Research has always been a focus area for National Institute of Technology Durgapur with the faculty members and the students engaged in quality research in various domains. The same is reflected in the large number of publications and citations in premier journals of the world. This has also helped the Institute jump from 47th to 29th in the NIRF (Engineering). The Institute has recruited very energetic young faculty members in recent times with more faculty members likely to join soon in the ongoing recruitment drive.

The existing sanctioned annual intake of only 75 PhD seats has become highly inadequate to support and sustain the research activities spearheaded by the faculty members in the Institute. It may also be noted that NIT Durgapur, in keeping with the NEP-2020, has planned to initiate more research in areas of direct societal impact, which will need an urgent increase in the sanctioned PhD seats.

Accordingly, it is proposed to kindly consider the sanction of 25 additional PhD seats to the institute to help it embark upon a higher research trajectory. An additional fund of Rs 1 crore [25 x Rs 4 lakhs] will be required for their fellowship under the head OH-31.
