

Step 2: Online enrollment on July 19, 2023 (10:00 AM to 4:00 PM).

After registration fill up the required information and upload the distinct and clear copies of the following documents. After preview, SUBMIT. You will receive intimation of enrollment and will be able to download the copy after approval. The intimation of academic activity and others will be sent from time to time.

Step 5: Click on "Continue"- In the page fill up the details in the appropriate fields.
