Page No 9- Requirement / description of Operating Systems and Virtualization Software Support may be read as - “Red Hat Enterprise Linux (RHEL) --- License should be Provided for Latest Version for 03 Years Premium. Support for Microsoft Windows Server, SUSE Linux Enterprise Server (SLES), VMware”

Page No. 9 - Requirement / description of Warranty may be read as – “Server Warranty from OEM includes 3-Year Parts, 3-Year Labor, 3-Year Onsite support with next business day response”.

Page No 11- 1.2 48 TB Network Attached Storage - In the Requirement / description of Operating System & Clustering Support – The requirement of “HPE-UX” is made as optional

Page No 17- 3.2 Managed Layer 3 Access switch - The Requirement of “IEEE 802.1ae MACsec” is made as optional

Brief Description of Processor may be read as “Intel i5 11th gen/RYZEN 5, 2.3 GHz base frequency, 8 MB cache, 4 cores” .

Brief Description of Graphics may be read as “Integrated Graphics HD 620 / RADEON”

4.4 Desktops Computer –

Specification of Processor may be read as “Intel® 10th Generation Intel Core i5 10400 / RYZEN 5 4600G, with minimum base frequency of 2.9 Ghz, 6 Cores, 12 MB Cache or higher”

Specification of Chipset may be read as “Intel B 460 / AMD B Series (Latest)”

Page No 21- 4.4 Desktops Computer - Specification of Graphics may be read as “Intel Integrated 630 Graphics / AMD RADEON”

Page 10- 5.1/ Tentative list of items require for shifting under SI No 10. - may be read as “Supplying and Laying of Cat6A UTP cable inside the PVC conduit / Channel”

Page no 22- Credentials section may be read as,

“The bidder must have the following credential:

- If the bidder is not the manufacturer of the device, it must produce the Manufacturer’s Tender Specific Authorization certificate regarding the sales & servicing of the device.
- Bidder must produce credential (e.g. Purchase Order, Contract Order etc.) of sale similar type of equipment in the recent past (LAST 3 years and Should have THREE Orders/Contracts and Their Completion Certificates).
- Bidder must have at least Three (3) Years and Associated OEM must have Ten (10) years of business operation in the related field in INDIA.”
