NOTIFICATION

Sub: Payment of registration fee by the students of B.TECH/DUAL DEGREE/INTEGRATED, PG and Doctoral Programme for Odd Semester, 2018 – 2019 including the students admitted under ICCR / DASA / GOI, MEA [E] / GOI, MEA [W].

1. Students of <u>B. Tech / Dual Degree / Integrated M. Sc, Post-Graduate and Doctoral programmes</u> are required to register themselves by paying the registration fee for their respective programme of Odd semester 2018 – 2019 sessions by July 13, 2018 (Friday) – by online mode of payment.

2. Payment of semester registration fee by all students (including students of idle semester) within

prescribed date is mandatory.

3. The students of B.Tech/Dual degree/Integrated M. Sc, Post graduate and Ph.D. Programmes are advised to visit website www.amanmovement.org in order to fill up their individual affidavits online towards monitoring of National ragging prevention program launched by University Grants commission. At the time of forth – coming Odd semester registration 2018 – 2019, individual student should enclose a duly signed (self) printout of such anti-ragging affidavit submitted online, along with his /her registration fee payment receipt at the academic section within stipulated date. The said online submission of anti-ragging affidavit needs no stamp paper or oath commissioner. Such online submission has two parts; part I is for filling up personal details (containing 05 pages) and part II is confidential survey format. The exercise of filling up and submission of the affidavit by the individual student is mandatory in nature and shall be followed strictly.

4. All B.Tech/Dual degree/Integrated programme students are required to pay / deposit semester registration fee online by SBI e-collect mode to the Institute account no. 30759768090 at the NIT Durgapur Branch of the State Bank of India (IFS code SBIN0002108). Payments in the form of cash, bank draft, cheque etc are not permitted directly to the bank. Tuition fee and other compulsory fee for students registering under quota of ICCR, DASA, MEA GOI are displayed in institute website for necessary payment. It is also advised that the students admitted under ICCR / DASA / GOI, MEA[W] may open an account in the bank located within NIT campus which may help them for payment of fees by transferring the amount of fees from their account (Authenticated

Certificate for US Dollar to INR conversion to be attached).

The payment portal of SBI gateway for institute semester registration fees will be made operational tentatively from May 18, 2018 (Friday). The student who availed bank loans / educational loans are advised to contact their respective branch of bank to transfer the amount required for the individual student through NEFT / RTGS mode to the above mentioned institute account number 30759768090.

- 5. All <u>PG (M .Tech , MBA , MCA ,M.Sc, MSW)</u> and <u>Ph.D</u> students are required to pay / deposit semester registration fee online to the institute <u>account no. 8569101000352</u> at the NIT Durgapur branch of the Canara Bank (<u>IFS Code CNRB0008569</u>). Payments in the form of cash, bank draft, cheque etc are not permitted directly to the bank .Tuition fee and other compulsory fee for students registering under quota of ICCR , DASA ,MEA GOI are displayed in institute website for necessary payment . it is also advised that the students admitted under ICCR / DASA / GOI,MEA[E] /GOI,MEA[W] may open an account in the bank located within NIT campus which may help them for payment of fees by transferring the amount of fees from their account (Authenticated certificate for US Dollar to INR conversion to be attached).
 - The payment portal of Canara Bank gateway for institute semester registration fees will be made operational tentatively from May 18, 2018 (Friday). The student who availed bank loans / Educational loans are advised to contact their respective branch of bank to transfer the amount required for the individual student through NEFT / RTGS mode to above mentioned institute account number 8569101000352.
- 6. After payment of semester registration fee all the regular students have to undergo Institute Semester Registration online. The Chanakya portal for semester registration will be activated for facilitation of submission tentatively during August 2018.
- 7. Students having **backlog papers** are required to registered themselves in the Institute semester registration process through Chanakya portal on payment of Rs. 500.00 per semester for the backlog paper examination for the particular semester of the programme. In B.Tech/Dual degree/Integrated programme a student can register in maximum number of six theory subjects inclusive of backlog courses, if any. The students, however must register all backlog papers first.
- 8. The students need to submit printout of Chanakya online semester registration form to the respective dealing assistant in the academic section along with the self-attested copy of the bank payment receipt within the stipulated dates of registration (tentatively by last week of August 2018) along with anti-ragging online application (printout of Chanakya online semester registration form + self-attested copy of the bank payment receipt + anti-ragging online application).
- 9. Students who are unable to pay their semester registration fee in Phase I by July 13, 2018 (Friday) for B.Tech/Dual degree/Integrated, PG and Doctoral Programme due to any compelling reason may pay their registration fee between July 23, 2018 (Monday) to July 27, 2018 (Friday) with an additional payment of rupees five thousand only to the bank online through SBI e-collect (for B.Tech/Dual degree/Integrated programme students) and through Canara bank online payment mode (for M.Tech, MBA, MCA, M.Sc, MSW and Ph.D programme).
- 10. B.Tech/Dual degree/Integrated programme students desirous to avail fee waiver or remission of fee, are to submit original copy of family income certificate issued on or after April 01, 2018 by the competent government authority as mentioned below.
- 11. A student failing to register himself / herself in a semester by paying requisite fees within the stipulated date will be treated as "NOT ON ROLL".
- 12. Classes of Odd semester 2017 18 of all programmes shall start from July 09, 2018 (Monday).
