OFFICE ORDER

A meeting of the Disciplinary Committee of the Institute was held on 18.09.18 at 11:00 AM, subsequent to the complaint received from a large number of students on the incident of student infighting happened around 3:00PM at Hall III on 17.09.2018. The meeting was followed by another meeting which was urgently held on 17.09.2018 at 5:00 PM, participated by the Director and other officials of the Institute. The accused students were interrogated and based on their submission and interaction with them, charges against their in-disciplinary activities were noted and the following preliminary actions have been recommended by the Disciplinary Committee.

- 1. Based on the investigation and past records the students **Sri Amit Kumar (17EC8047)** and **Sri Prince Kumar (17MM8021)** have been found guilty. Therefore they are suspended from all academic activities for the academic session 2018-19 with immediate effect. They are also instructed to vacate the hostel within 24 hours from the issuance of this office order. If they are further seen in the campus during the suspension period they will be permanently expelled from the Institute.
- 2. The parents of the following accused students are required to meet Disciplinary Committee on 26.09.2018 at 3:30 PM in the Institute for final penal action.
