NOTIFICATION

Sub: Payment of Odd Semester Registration fee 2019-2020 of B. Tech / Dual Degree / Integrated, PG and Doctoral Programme.

- Student of B. Tech / Dual Degree / Integrated M. Sc, Post-Graduate and Doctoral Programmes
 are required to register themselves by paying the semester registration fee for their respective
 programme of Odd Semester 2019-2020 sessions by July 19, 2019 (Friday) by online mode of
 payment.
- 2. Payment of semester registration fee by all students (including students of idle semester) within prescribed date is mandatory.
- 3. The students of B. Tech / Dual Degree / Integrated M. Sc, Post-Graduate and Doctoral Programmes are advised to visit website www.amanmovement.org in order to fill up their individual affidavits online towards monitoring of National Ragging Prevention Programme launched by University Grants Commission. At the time of forthcoming Odd Semester registration 2019-2020, individual student should enclose a duly signed (self) printout of such anti-ragging affidavit submitted online, along with his / her registration fee payment receipt at the Academic Section within stipulated date. The said online submission of anti-ragging affidavit needs no stamp paper or oath commissioner. Such online submission has to parts; Part I is for filling up personal details (containing 05 pages) and Part II is confidential survey format. The exercise of filling up and submission of the affidavit by the individual student is mandatory in nature and shall be followed strictly.
- 4. All B. Tech / Dual Degree / Integrated Programme students are required to pay / deposit semester registration fee online by SBI e-collect mode to the Institute account of State Bank of India, NIT Durgapur Branch (Account no. 30759768090; IFS Code SBIN0002108). Payments in the form of cash, bank draft, cheque etc are not permitted directly to the bank. Tuition fee and other compulsory fee for students registering under quota ICCR, DASA, MEA-GOI are displayed in Institute website for necessary payment. It is also advised that the students admitted under ICCR / DASA / GOI, MEA [W] may open an account in the bank located in NIT campus which may help them for payment of fees by transferring the amount of fees from their account.

The payment portal from SBI gateway for Institute semester registration fees will be made operational tentatively from **June 18, 2019 (Tuesday).** The student who availed bank loans / educational loans are advised to contact their respective branch to transfer the amount required to the individual student through NEFT / RTGS mode to the above mentioned Institute **account number 30759768090** within stipulated date.

- All PG (M. Tech, MBA, MCA, M. Sc, MSW) and Ph.D students are required to pay / deposit semester registration fee online to the Institute account of Canara Bank, NIT Durgapur Branch (Account no. 8569101000352; IFS Code: CNRB0008569).
 - The payment portal of Canara Bank gateway for Institute semester registration fees will be made operational tentatively from **June 18, 2019 (Tuesday)**. The student who availed bank loans / educational loans are advised to contact their respective branch to transfer the amount required to the individual student through NEFT / RTGS mode to the above mentioned Institute **account number 8569101000352** within stipulated date.
- After payment of semester registration fee all the regular students have to undergo Institute semester registration online. The Chanakya portal for semester registration will be activated for facilitation of submission during September 2019.
- 7. Students having **backlog papers** are required to register themselves in the Institute semester registration process through Chanakya portal on payment of Rs. 500.00 for the backlog paper examination for the particular semester of the programme. Such students are allowed to register for maximum **TWO backlog** papers in addition to **all regular paper** of current semester.
- 8. The students need to submit printout of Chanakya online semester registration form to the respective dealing assistant in the Academic Section along with the self-attested copy of the bank payment receipt within the stipulated dates of registration along with anti-ragging online application (printout of Chanakya online semester registration form + self-attested copy off the bank payment receipt + anti-ragging online application + filled in Examination application form).
- 9. Students who are unable to pay their semester registration fee by **July 19, 2019 (Friday)** may pay their registration fee online between **July 23, 2019 (Tuesday) and July 31, 2019 (Wednesday)** with late payment fee to the respective bank at SBI e-collect (B. Tech/ Dual Degree/ Integrated Programme) and Canara Bank (M. Tech. / MBA / MCA / M.Sc / MSW and PhD Programme).
- 10. A Student failing to register himself / herself in a semester by paying requisite fees within the stipulated date will be treated as "NOT ON ROLL".
- 11. Classes of Odd Semester 2019-20 of all programmes shall start from July 08, 2019 (Monday).
