**Eligibility Criteria**

- 1) The Candidate should have secured at least 7.5 CGPA at the time of submission of her/his nomination.
- 2) The candidate must have a proven record of active participation in activities related to the different student clubs, and the academic/cultural/sports attainments of the candidate shall be taken into consideration by the Election Commission for considering individual candidature.
- 3) There should be no past record of Disciplinary Action against the candidate issued by the Institute Disciplinary Committee.
- 4) Students having any outstanding mess dues or involved in any act of indiscipline and punished will not be eligible to file nomination. Mess dues clearance certificate up to December 2019 from the concerned Warden to be enclosed with nomination paper positively failing which nomination will be cancelled.

Any eligible student willing to contest in the above election will have to submit his/her Nomination paper (Form available from 06-01-2020 starting 11:00 A.M. to 05:00 P.M on weekdays with office of the Dean (SW) duly completed along with clearance of mess dues certificates from the Warden of the present hostel to the Dean (SW) by 05:00 P.M. of 13<sup>th</sup> January, 2020 & will personally sign Register maintained by Office of Dean (SW) for the purpose of record.

Any student having submitted his/her Nomination paper, willing to withdraw from the election, will have to submit an application to that effect to the Election Commission at Office of the Dean (SW) between 11:00 A.M. and 05:00 P.M. on 15<sup>th</sup> January 2020 & will personally sign a register maintained by the Dean (SW) – Office for the purpose of the record. The details of the time of the election by ballot will be notified separately.
