Audit Query on the accounts of the office of the Director, NIT, Durgapur for the period from 1.4.2015 to 31.3.2016

Subject: Non-deduction of Water Charges:Rs.48,250/-

By virtue of the O.M. No-18011/1/2009-pol-III dated 28.04.2011 Director of Estates, Government of India, revised the 'License Fee' along with Water Charges recoverable for residential accommodation available in General Pool and also in Departmental pools of Ministries/Departments of the Government of India, all over the country. Retrospective effect of such order was given from 01.07.2010. Accordingly, all the Ministries/Departments were requested to take action to recover the Water Charges in accordance with the order mentioned above in respect of accommodation under their control.

National Institute of Technology Durgapur did not recovered Water Charges from the RE College Model School situated in the campus at rates circulated by the Ministry of Urban Development.

Test check of records revealed that the Institute had not recovered Water Charges from 01.09.2010 leading to non-recovery of Water Charges of Rs.48,250/- (Rs.720 x 67 months) till 31.03.2016.
