CIRCULAR


In accordance to the directive of the Government of India, Ministry of Finance, Department of Expenditure vide Office Memorandum No. 1/1/2020-E II (B) dated 23rd April, 2020 that in view of the crisis arising out of COVID-19, the additional installment of Dearness Allowances payable to Central Government employees and Dearness Relief to Central Government pensioners, due from 1st January, 2020, 1st July, 2020 and 1st January, 2021 shall not be paid. However, Dearness Allowances and Dearness Relief at current rates will continue to be paid.

As and when the decision to release the future installment of Dearness Allowances and Dearness Relief due from 1st July, 2021 is taken by the Government, the rates of Dearness Allowances and Dearness Relief as effective from 1st January, 2020, 1st July, 2020 and 1st January, 2021 will be restored prospectively and will be subsumed in the cumulative revised rate effective from 1st July, 2021. No arrears for the period from 1st January, 2020 till 30th June, 2021 shall be paid.

Further, the Comptroller & Auditor General of India has provided the following guidelines for compliance to maintain the expenditure limit during the period from 01.04.2020 to 30.06.2020 vide Letter No.100-Budget/Res Bes/03-2019 dated 22.04.2020:

1. Only regular salaries including Children Education Allowance to be made. Payment in respect of other allowances such as salary arrears, L.T.C, Leave Encashment etc. may not be made during the period from April to June, 2020 without approval of the Government of India.
2. Advance payment only in emergency cases may be made.
3. Expenditure may be incurred only on committed liabilities which cannot be avoided. However, any arrears for previous period may be deferred till further orders. No expenditure may be incurred under sub-head 'Special Contingencies' during 1st quarter (April to June, 2020).
4. Expenditure may be incurred only for outsourced staff and casual staff during the period.
