## CIRCULAR

In accordance to the Office Memorandum No. F.N. 11-2/2018-SC/ST dated 1<sup>st</sup> October, 2020 issued by the Ministry of Education ( Shiksha Mantralaya), Department of Higher Education (SC/ST Cell), Government of India with a directive in building of college, universities, institutions, autonomous bodies, subordinate offices etc. for Barrier Free Environment for Persons with Disabilities and Elderly Persons, 2016 ( RPwD Act, 2016) is properly implemented and ensuring all the new buildings of State Government or agencies subordinate to them, are designated to be fully accessible. The Ministry has requested to provide the details of accessibility features ( building- wise) of the institutions alongwith photographs by 1<sup>st</sup> of every month and presently for the month of January, 2020 to September,2020 directly to D/o, EPwDs and information for onward months by 1<sup>st</sup> of every month to SC/ST Cell, so that same could be uploaded on the MIS portal of AIC & also to be forwarded to D/o EPwDs.

In view of the above, Office Memorandum No. F.N. 11-2/2018-SC/ST dated 1<sup>st</sup> October, 2020 and 21<sup>st</sup> November, 2019 issued by the Ministry of Education ( Shiksha Mantralaya), Department of Higher Education (SC/ST Cell) and D.O. No.4-83/2016-AIC (Vo. II) dated 29<sup>th</sup> October, 2019 issued by the Ministry of Social Justice & Empowerment, Department of Persons with Disabilities ( Divyangjan), Government of India are enclosed herewith for compliance.

In this context, all Heads of the Departments / Sections/ Centers and Central facilities of the Institute are requested to make a report on the above and forwarded the same to the undersigned for onward submission to D/o, EPwDs with information to SC/ST Cell.
