BRIEF FACTS LEADING TO THE APPEAL:-

I on behalf of my client filed an application under
Section 6 of the Right to Information on 24.06.2019
and the respondent authority concerned provided
information as per my application vide letter dated
7th August 2019, which was received by my client
on 10th August 2019, providing information of my
application, the particular of which are given below:

- i) What are the total/entire retirement benefits my client is entitled for ?
 - ii) How much amount my client received as his retirement benefits and how much amount is lying pending and/or recoverable or to be paid to my client ?
 - iii) Whether my client is entitled for TA on retirement and composite grant as his retirement benefits, if not, then why he is not eligible for TA on retirement and composite grant?
 - iv) Why till date my client has not received and/or paid to my client his all other retirement benefits ?
 - v) What are the existing rules of National Institute of Technology Durgapur relating to providing pension to my client's wife after the sudden demise of my client ?
 - vi) What are the steps my client's wife shall take for getting pension uninterruptedly?
 - vii) What are the steps taken by National Institute of Technology Durgapur, in respect of my client's several complaints against () Dept. NITD) ?
 - viii) Please supply my client a copy of the rules and regulations and other connected papers

and/or documents relating to retirement benefits of my client and his wife on usual undertaking.

But unfortunately the respondent herein, being the information officer totally ignored and/or rejected the information no.vii) of my said application stating inter alia : " The information is not related with Deputy Registrar (F & A)".

Not only that there is no whisper and/or answer and/or misleading provided by the information officer in respect of the information no.vii) of my said application.

GROUNDS:-

- I. The Information Officer erred in not consideration of the information no.vii) of my application and not at all discussing the points raised in the said application.
- II. The Information Officer erred in providing information of information no.vii) and provided information without at all considering the grievance of the applicant in respect of the information no.vii) of my said application..
- III. The information officer could not in reality given answer to that effect and it amounted to depriving the applicant in respect of the information no.vii) of my said application.
- IV. The information officer's the impugned information dated 07.08.2019 is totally opposed to the natural justice and equity.

- V. FOR THAT the impugned information is otherwise bad in law.

LIMITATION:

The authority concerned provided information vide letter dated 07.08.2019 which was received by my client on 10.08.2019 which is within the appeal period. Hence there is no delay in preferring this appeal.

RELIEF SOUGHT:

Direct the Respondent being the Information Officer to disclose the information as sought for in terms of the letter/application dated 24.06.2019 in respect of the information no.vii) of my said application i.e. What are the steps taken by National Institute of Technology Durgapur, in respect of my client's several complaints against [redacted] (Dept. NITD) ?, Photocopy of the application dated 24.06.2019 and information letter dated 07.08.2019 along with all its annexure are annexed hereto and collectively marked with letter "A".

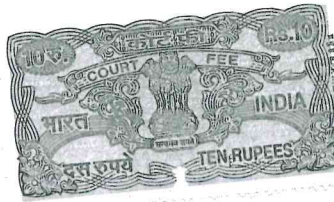
