Apropos of the aforementioned subject,Vis - a -vis Ref.Ot.Nos. (1),(2) & (3) respectively,I would like to lay before you the following facts for your early response from you in particular, for the requirement of informations Under RTIA Act,2005:-

- A) First of all,kindly note that the reply letters Vide Ref. Nos.and date as mentioned at Ref.Point No.(3) hereinabove by your Asstt.Registrar & CPIO with enclosure thereof i.e.a copy of Inter Departmental Memo from your Deputy Reg.(Estt.) to the Asstt.Registrar & CPIO,N.I.T.,Durgapur Vide No. NITD/RTI/Estt/3216/207 dated-28th August,2009 is not transparent and clear from the View point of---i)Whether Sarkar, who joined in your N.I.T.,Durgapur on 01.02.2007 on lien as Professor of Training Placement and Student Welfare

was a Contractual OR on regular Permanent post, who(i.e. worked Upto 31.01.2012 in your N.I.T. at Durgapur or any other Place/Office of N.I.T. Durgapur other than Durgapur City ?

B) Next Question Under R.T.I.Act,2005 I seek to know from you as to whether during the tenure of his services in N.I.T,Durgapur on lien basis,committed any "Major Misconduct" for which,he was Suspended pending enquiry and was sent to Kolkata Office of N.I.T.,Durgapur. The specific answer as YES Or NO is desired from your end with some details as to why he was sent to Kolkata.In Other Words,whether it is to be construed that your NIT Durgapur's Training,Placement and students Welfare Deptt., is situated at Kolkata and not of N.I.T.,Durgapur College Premises ?

C) Kindly let me know from which Organisation/Institution or Industry he had joined your N.I.T.Durgapur College Campus at Durgapur and is this business of hiring "on lien basis" for your specific business needs of N.I.T.,Durgapur and if so,whether due approval for such employment "On Lien basis" for was obtained from the concerned Competent Authority of Technical Education of Govt.of India(Deptt.).

D) Lastly,it is earnestly requested to please provide me the above noted informations in respect of Sri ,Ph.D an ex-employee "On lien basis" of N.I.T.,Durgapur.

Looking forward to your prompt reply in line with the Provisions of R.T.I.Act,2005 to me at an early date.
