Subscription in each of those three months for Thrift Fund A/C was Rs. 30 and I did not have any Loan (Annexure-6). $\text{Rs. } 1030 - \text{Rs. } 30 = \text{Rs. } 1000$ was an extra amount of deduction in each month. So an extra amount of total deduction of Rs. 3000 ($\text{Rs. } 1000 \times 3$) was made from the salary of those three months.
