Quotations are invited from all prospective bidders for supply, installation (installation includes fixing of the items on ground with cement, chips, sand etc. up to appropriate depth for security & stability) & commissioning of equipment for staff club playground, as per the specifications, terms and conditions mentioned below. All bidders are required to address their bid documents to the Dy. Registrar (P&S), National Institute of Technology, Durgapur, (W.B), Durgapur-713209 and drop the same in sealed condition in Purchase and Stores Section.
- 2. The quotation is to be submitted in two parts in separate sealed envelopes which is then to be put in one large envelope & sealed:

- 5. All price quoted must remain open for acceptance for 60 days from the date of opening of the bid. Prices are for delivery. Free delivery to N.I.T., Durgapur-9, as per conditions mentioned in Purchase Order. Successful firms will have to supply, install & commission the items within 15 days after issuance of Purchase Order, unless otherwise specified in the Purchase Order. L.D. clause of 0.5% per week of delay is applicable. The Institute reserves the right to cancel the order on accumulation of LD charge of 10% or more. Installation includes fixing of the items on ground with cement, chips, sand etc. up to appropriate depth for security & stability.
- 6. EMD @ Rs. 4000/-(Rupees Four Thousand) to be submitted in the form of Demand Draft from any commercial bank having its branch at Durgapur, in favour of Director, NIT Durgapur payable at par. Same will be returned to unsuccessful vendor(s) on application on completion of the entire process and to the successful vendor after successful delivery completion.
- 7. Goods are required to be consigned to the Director, NIT Durgapur unless otherwise instructed. All supplies are to be guaranteed against manufacturing defects and must be replaced at suppliers' cost. The actual quantity of requirement of items may vary from what is indicated in this notice which is only an estimate. The decision of the Institute regarding the variant and quantity to be purchased is final. Warranty certificate is to be provided with the bill.
- 8. Changes if any to this notice will be notified as corrigendum. All disputes are subject to jurisdiction of Hon. Durgapur court. The Institute may unconditionally and without assigning any reasons, reserves the right to accept or reject the lowest quotation or any other quotation or cancel the process without incurring any liability whatsoever.
