## Corrigendum to Tender No. NITD/03/P&S/101/18-19, dated 08/02/2019 Supply, Installation & Commissioning of Goods (Furniture, Computer, Software etc.) for HSS Language Lab, NITD on Turnkey Basis.

Reference is made to *Tender No. NITD/03/P&S/101/18-19*, dated 08/02/2019 for "Supply, Installation & Commissioning of Goods (Furniture, Computer, Software etc.) for HSS Language Lab, NITD on Turnkey Basis". The Pre-bid meeting against the said Notice Inviting Quotation was held on 18/02/19. The following points are clarified:

- 1. Computer (Item code: Item 2):
  - a) Internal DVD RW drive to be read as "Internal DVD RW with Speed 16 x or more"
  - b) Monitor Size to be read as '19.5 inch minimum' instead of '19.6"'.
  - c) Inbuilt wifi to be added to the specification
  - d) "Security for inbuit......diagnostic" to be read as "Security-TPA 2.0"
     All other specifications to remain unaltered.
- 2. UPS (Item code Item 5): Backup time of UPS to be minimum 30 minutes. All other specifications to remain unaltered.
- 3. Electrical wiring from output end of UPS to system, with all electrical accessories is the responsibility of the bidder. Electrical accessories as required should be ISI certified.
- 4. Student Table-4 seater (Item code-Item 10): The length of the table to be "2700 mm" instead of "2400mm". All other specifications to remain unaltered.
- 5. EMD: EMD can be submitted as Demand Draft (as per details mentioned in tender document) or as Bank Guarantee of any commercial bank of the required amount. No other form of EMD will be acceptable. Bank Guarantee to be valid for the entire bid validity period. Original EMD Demand Draft/Bank Guarantee should be sent along with hard copies at least 48 hours prior to opening of technical bids failing which bid will be technically disqualified. In addition scanned copy of same is also required to be uploaded on CPP Portal.

All other details & terms & conditions mentioned in the notice inviting quotation remain unchanged. Bidders should keep both the tender document & the corrigendum in mind while submission of bids.
