(b) Two (2) similar works, each of value not less than 60% of the estimated cost, or  
(c) One (1) similar work of value not less than 80% of the estimated cost, all above amounts rounded off to a convenient full figure of nearest Rs. 10, in the last 7 years ending on the last day of the month previous to the one in which the tenders are invited in any Govt./Semi Govt./Quasi Govt./Autonomous bodies. - 1) Tender must be submitted online in two parts,
  - (a) Technical bid and (b) Price bid.
- 2) Tenderers have to upload the following documents:
  - i) GST Registration Certificate.
  - ii) Latest valid licenses like Trade License, ESI, EPF, whichever is applicable.
  - iii) Requisite Credentials as mentioned above.
  - iv) Bank Solvency certificate = 20% of the estimated value
  - v) Voter I.D., Aadhar Card
  - vi) Latest IT returns
  - vii) Separate demand draft towards cost of tender paper as mentioned above
  - viii) Scanned Copy of a single Demand Draft of requisite value for the Bid Security/EMD as per NIT. NSIC/MSME Registered bidders who wants to claim the EMD exemption need to submit the **Scanned copy of Latest and valid NSIC/MSME Certificate** for the same nature of works in place of the DD of the EMD.

ix) Any other relevant documents as specified in the General Tender Document duly signed with date and stamp on all pages.

- 3) Earnest money as mentioned, is to be deposited along with tender, in the form of an A/C payee bank draft/pay order/BG in favor of “National Institute of Technology, Durgapur” payable at SBI, NIT Durgapur branch Durgapur-713209 and to be enclosed with in part “A” of the tender.
- 4) EMD and cost of tender paper are exempted for bidders having certificate from NSIC/MSME
- 5) Bidders can also download and get necessary information regarding tender documents from <https://eprocure.gov.in/cppp>
- 6) Works will be executed as per CPWD/WBPWD specifications and DSR 2018 (Civil Maintenance) for items and tenderers has to quote their rates in percentage above/below. For items other than DSR 2018/WBPWD 2017 (Civil Maintenance) market survey will be done to fix the rates.
- 7) The tenderers will have to provide one supervisor for civil work having the requisite qualification (minimum Diploma in Civil Engineering).
- 8) Rates quoted shall be inclusive of all taxes. No price escalation shall be paid at any circumstances.
- 9) The agency must attend every urgent maintenance work immediately whenever called for. In case of failure, penalty of Rs. 1000/- will be made and deducted from their bill. Any breakage or damage to the property of Institute by labors of agency has to be compensated by the agency.
- 10) Tender calling authority reserves the right to cancel any tender or close agreement any time without giving any reasons.
