The technical bid should consist of all technical details along with commercial terms and conditions. Financial bid should indicate item wise price for the items mentioned in the technical bid in the given format. The Technical bid and the financial bid should be submitted Online within 29/10/2019 (18.00 Hrs).</p>
3	<p>EMD (if applicable): The bidder should submit an EMD amount of ₹12,000/- through demand draft of any nationalized bank in favour of 'NIT Durgapur' payable at Durgapur. 22	Installation & Demonstration Installation and demonstration of the equipment should be done within one month of the arrival of materials at the site of NIT Durgapur. In case of any miss-happening/damage to equipment and supplies during the carriage of supplies from the origin of equipment to the installation site, the supplier has to replace it with new equipment/supplies immediately at his own risk. Supplier will settle his claim with the insurance company as per his convenience. NIT Durgapur will not be liable to any type of losses in any form.
