- All the candidates who have accepted a seat during JoSAA-2020 rounds 1-6 are required to login to their account on JoSAA portal from 9th to 13th November, 2020 to SECURE the admission in the allotted Institute.
- It is mandatory for every candidate to pay PARTIAL ADMISSION FEE (Rs. 40000/- for GEN, GEN-EWS, OBC-NCL and Rs. 20000/- for SC, ST, PwD candidates) by clicking the link given on the JoSAA portal through online mode. This partial admission fee can be paid using Net Banking / Debit card / Credit card or State Bank of India e-challan.
- The total fees paid during the whole process of counselling will be transferred to the Institute as ADMISSION FEE Including the FIRST SEMESTER fees where you are finally admitted through the counselling process of JoSAA/ CSAB.
- For NIT DURGAPUR the rest amount payable (if any) to be paid before enrolment for JoSAA round candidates as per the notice- NITD/Acad/20-21/UG/1; dated 28/10/2020. Any excess amount paid will be refunded to the bank account recorded at the time of enrolment.
- The payment to be made online through NEFT / IMPS to the NIT DURGAPUR account of the State Bank of India, NIT Durgapur Branch (Account no. 30759768090; IFS Code SBIN0002108). Payments in the form of cash, bank draft, cheque etc directly to the bank, are not permitted.
