Sub: Norms of expenditure for activities under TEQIP III (w.e.f 29.7.19)


The following norms are proposed for the different activities under TEQIP – III of NIT Durgapur:

- 1. Faculty research visit in India:** Each faculty may attend conference (oral presentation of paper)/Training/Short term course/workshop in India at least duration of 2 to 5 days during the TEQIP III period with a maximum support of **Rs 50,000**, subject to availability of fund.
- 2. Faculty research visits abroad as per MHRD guidelines:** Each faculty may attend a conference/Research collaboration visit etc. abroad with a maximum support of **Rs. 1, 50,000** towards passage fare, registration fee, per diem allowance as applicable, visa fee, medical insurance, etc from TEQIP III as per the norms of MHRD and TEQIP-III, subject to availability of fund. Only one research visit in abroad shall be supported by TEQIP – III to each faculty member during the entire TEQIP – III period.
- 3. Staff training:** Staff members may undertake any number of training in India organized by industries/institutes /other organization or in – house.
- 4. Organizing Workshop /Short -term courses, etc :** A maximum financial support of **Rs. 1,00,000, Rs. 1,50,000** and **Rs. 2,00,000** shall be admissible from TEQIP III for organizing a 2, 3 and 5 days programme respectively.
- 5. Organizing National conference (at least 3-days programme):** A maximum financial support of **Rs 1, 50,000** shall be admissible for organizing a national conference under TEQIP III..
- 6. Organizing International Conference (at least 3-days programme):** A maximum financial support of **Rs 2,50,000** shall be admissible for organizing conference under TEQIP III .
- 7. Organizing Workshop/Short-term course/National/International conference in collaboration with mentee Institute (NIT Nagaland/Dumka Engineering College):** A maximum financial support of **Rs. 1,00,000, Rs. 1,50,000** and **Rs. 2,00,000** shall be admissible from TEQIP III for organizing a 2, 3 and 5 days programme respectively.
- 8. Invited lecture by experts from industries (one – day programme):** A grant of **Rs .50, 000** (maximum) inclusive of all, shall be admissible from TEQIP III for invited lecture (minimum 2 contact hrs) from industries. This will include an honorarium of **Rs.5, 000** to the expert.
- 9. Improvement in students learning:** A maximum fund of **Rs.10, 000** shall be admissible from TEQIP III to each full time regular student for research assistantship for attending workshop/short term course/presenting paper (oral) in conference in India/students internship/industry visit/summer training/students' competition etc. as per the existing Institute norms.
- 10. Research & Development:** A maximum fund of **Rs.30, 000** shall be admissible to each regular faculty and trainee teacher from TEQIP III for procuring research consumables/spares/repair of equipment and small items required for B.Tech. and M.Tech students' projects.
