Step 3: Enter PID and DOB in dd/mm/yyyy format

PID is the “INITIALS OF FIRST NAME AND LAST NAME”, For Example – ASHOK KUMAR DUBEY will have PID as “AD”.

Step 4: Click on ‘Submit’- In the next page fill up the details in the appropriate fields.

Step 5: Click on ‘Save and Continue’ – In the following page upload the requisite documents.
